**ORDER GRANTING THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS'
ORE TENUS MOTION TO CONTINUE TRIAL**

THIS MATTER came before the Court upon the Official Committee of Unsecured Creditors of TOUSA, Inc., *et al.*'s ("the Committee's") Ore Tenus Motion to Continue Trial (the "Motion"). Having heard and considered the Committee's Motion and the arguments of counsel, and for the reasons stated on the record, it is **ORDERED AND ADJUDGED** that:

1. The Committee's Motion is **GRANTED**.
2. Trial is **CONTINUED** until August 28, 2009, at 9:00 AM.
3. The continued trial will last for no longer than one day, and testimony will be limited to the rebuttal testimony of Amy Benbrook and Charles Hewlett.
4. Discovery is **RE-OPENED** to the extent that the defendants may take the depositions of Amy Benbrook and Charles Hewlett concerning their rebuttal opinions. The depositions shall be at a date and location mutually agreed upon by the parties.
5. No party may file or present any additional, corrected or modified expert reports.
6. The deadline for presenting Proposed Findings of Fact and Conclusions of Law to the Court is **EXTENDED** to September 4, 2009, at 5:00 PM.
